Supervisor Horton opened the meeting by commenting on the lovely weather. This brief meeting today is the organizational meeting. He stated there may be one change to the agenda which he will mention as we go through it.

Delaney of the Adirondack Park Local Government Review Board to represent its interests of local governments of the Adirondacks, and

WHEREAS, the town agrees to pay the review board the sum of Three Hundred Dollars (\$300.00) and will give periodic reports on the activities of the Adirondack Park Agency especially as such activities affect the residents of the town, now therefore be it

RESOLVED, that the Caroga Town Board does hereby move to approve the agreement and to authorize Town Supervisor Scott Horton to sign said agreement.

Supervisor Horton stated we are very fortunate, our Code Enforcement Officer in emergency situations has helped out with plowing and running the heavy equipment – the front-end loader. He keeps the parking lot at town hall cleared and he also does the fire department. Since the highway department is responsible for keeping the roads clean, Supervisor Horton stated there were talks with the fire department and it would be an added expense for them. The Supervisor stated that Anthony is not paid any additional money and it saves the Fire Company so they don't have to go out and contract for the service. It is a little bit of fuel and keeps the Fire Company open and operating in an effective manner. Mr. Delesky stated they do a good job. This saves the taxpayers money. Supervisor Horton noted that Mr. Fancher operates non-CDL required piece of town equipment on the road for the highway department to assist with emergency snow removal as necessary, and to insure to our insurance company that we are taking all of the necessary precautions,

Supervisor Horton asked that Anthony Fancher be added to the random drug testing pool.

Council Member DeLuca asked if this was allowed under the highway contract. Supervisor Horton replied it is not a union contract.

Council Member Glenn Seconded the resolution after resolution #2023-009 was created.

Discussion: Supervisor Horton stated the only reason we were meeting today was so that these salaries could be paid tomorrow.

Council Member Sturgess stated that he remembers that a head counselor was added last year to the summer recreation program. He asked if that position was listed. Council Member DeLuca thought it was something that got put in the budget. Supervisor Horton stated he did not have a salary for that. Council Member Sturgess would like to have that from the bookkeeper for the next meeting. The salary was not broken out in the budget. Council Member Sturgess thought there was a fifty or seventy-five cent difference in the pay rate from the regular councilor position.

Council Member Travis spoke earlier to the clerk about the minimum wage going up. The rate is now \$14.20. Council Member Travis had thought it was \$14.60 so these salaries are right on.

<u>RESOLUTION #2023 -009 to amend resolution #2023-003 to include naming the</u></u> <u>Webmaster</u> was offered by Supervisor Horton at the organizational meeting held Monday, January 2, 2023.

WHEREAS, the clerk asked if the Webmaster position was named earlier in the meeting and

WHEREAS, Supervisor Horton stated it was left out of Resolution #2023-003, now therefore be it

RESOLVED, that Resolution #2023 be amended to add the webmaster below boat stewards and boat wash coordinator naming Linda Gilbert as the Webmaster.

Seconded by Council Member Sturgess

Adopted by a vote of 5 Ayes: Horton, Glenn, DeLuca, Sturgess, Travis

Council Member Glenn received a notice from Marcus Harazin regarding Lakes Management. In the email he was reminded to list Mr. Olm in the naming of appointed personal and to list the salary. Mr. Harazin also wondered if the members of the lakes management committee or if the same ones would continue. Supervisor Horton stated the heads of the department do that. It has been tradition. Council Member Sturgess stated that is what we pay him for.

The good news was about reducing the costs to the town. After the last board meeting Mr. Harazin contacted Cathy Mc Glynn the director of the Invasive Species program from DEC again to request that DEC support the placement of an additional steward from their regional grant for coverage across the Adirondacks. The Adirondack Watershed Institute (AWI) has recently been awarded a 5-year contract to perform this function once again. Over the past few years, they have placed 2 stewards in Caroga. One at the Campsite launch and one at the launch at West Lake. At our request this season DEC is going to recognize our boat wash as an official inspection certification site and will place an additional steward there. This will provide 3 stewards for Caroga in 2023 and reduce the costs to the town.

Last week Mr. Harazin contacted the DEC to see when the new state requests for proposals of invasive species funding would be coming out. She stated that it could be very soon and urged us to get our information line up so we are ready to go. This will probably be a competitive application for 3 years of funding.

Supervisor Horton noted what is important is that we are looking at funding that we did not anticipate during the budget season. Council Member Glenn continued to read from the correspondence from Mr. Harazin. "This means that at the regular January meeting the Town Board should pass a resolution authorizing the Town to apply for any available funding through the NYS Department of Environmental Conservation Program for Invasive Species. Including funding for Programs for Aquatic Invasive Species Spread Prevention and Aquatic and Terrestrial Invasive Species Control." Council Member Sturgess suggested making the resolution now.

<u>RESOLUTION #2023 -010 to authorize the town to apply for any available funding</u> <u>through New York State Department of Environmental Conservation for Invasive Species</u> was offered by Council Member Glenn at the organizational meeting held Monday, January 2, 2023.

WHEREAS, the Town of Caroga is a town located wholly within the Adirondack Park, and

WHEREAS, the Town of Caroga has seven lakes within its borders which are used year-round recreationally by our residents and transient persons from out of the area, and

WHEREAS, the Town of Caroga first established an invasive species prevention program on July 10, 1984, and

WHEREAS, this town board as well as previous administrations and committees have dedicated countless hours to discussing invasives, specifically Eurasian Milfoil, which is prevalent in East Caroga Lake, a lake which is connected by a channel to West Caroga Lake the Town of Caroga, and

WHEREAS, the town spends close to \$200,000.00 annually on environmental programs to prevent the spread of invasive species both Aquatic and Terrestrial, which has been a burden to the taxpayers, now therefore be it

RESOLVED, that the Caroga Town Board does hereby support the efforts of the Weed Harvesting Coordinator, the Boat Steward and Boat Wash coordinator and their committee with this resolution to apply for funding from the New York State Department of Environmental Conservation for the prevention of Invasive Species in order to facilitate the continued boater education, prevention, and removal of invasive species in the Town of Caroga.

Seconded by Council Member Sturgess

Adopted by a vote of 5 Ayes: Horton, Glenn, DeLuca, Sturgess, Travis

Mr. Harazin did go on the portal and he has full access so he can apply for the grant.

Council Member Travis asked about the code officer being salaried and wondered if he would get paid to do the snow removal. Supervisor Horton stated he does not receive an extra compensation. Council Member Sturgess stated if he is not working at town hall it is the same money.

At 10:30 am Council Member DeLuca made a motion to adjourn. The motion was seconded by Council Member Travis. All board members were in favor of the motion.
